NOTICE FOR ELECTION OF ONE (1) DELEGATE AT E.C. RAILWAY, HAJIPUR.

WHERE AS the election of the Delegates of Eastern & North East Frontier Railway Cooperative Bank Ltd held on 31/08/2023 vide notice of the undersigned dated 09/08/2023. Out of total 118 (One hundred eighteen) delegates 117 (One hundred seventeen) delegates were elected on 31/08/2023 remaining one (1) seat vacant at the constituency No. HJP/C/1, due to non-submission of nomination paper by any interested candidate, wherein out of two (2) delegates assigned, one (1) delegate has been elected uncontested.

WHERE AS the election of the Board of Directors of Eastern & North East Frontier Railway Cooperative Bank Ltd held on 12/10/2023 vide notice of the undersigned dated 22/09/2023 and Sixteen (16) Directors have been elected from N.F.Railway and Eastern Railway accordingly.

WHERE AS the notice of reservation for Director Election of the Bank has been published vide Ref. No. CB/Notice/Director_elect/Sept23/2022-23 dated 15/09/2023 in accordance with the Banking Regulations Act and the article 243(ZJ/1) of constitution of India relating to Cooperative Societies as well as the Multistate Cooperative Societies Act & Rules 2002. Out of two (2) delegates assigned for the constituency no. HJP/C/1, One (1) vacant seat has been reserved for 'Female' candidates vide notice dated 13/12/2023.

WHERE AS the order of the Honorable Division Bench, High Court, Calcutta vide order dated 10.04.2024 has extended the time for completing the election process, but despite of making several correspondences to Railway Administration at Hajipur no response have been made till date. In order to give honor to the Constitution of India, the article 243(ZJ/1), election of one Female Delegate is required who will subsequently fill up the vacant post of Female Director in the Board.

Hence, in order to conduct the said delegate election at Hajipur, the undersigned hereby nominate two of the Officers of the Bank namely Mr. Supriya Roychowdhury, Manager as Election Officer and Mr. Biswajit Sen, Manager as Addl Election Officer.


